City	Is the City Auditor Appointed or Elected?	If Appointed, by Whom?
<u>Oklahoma City, OK</u>	Appointed.	Council. "The Council shall select a...City Auditor..."
<u>San Jose, CA</u>	Appointed.	Council. "The City Auditor shall be appointed by the Council."
<u>Arlington, TX</u>	Appointed.	Council. "There shall be appointed by a majority of the City Council, on the nomination of the Mayor or any member of the City Council, a City Auditor..."
<u>Austin, TX</u>	Appointed.	Council. "There shall be a city auditor who shall be appointed by the city council. The city auditor may be removed at the conclusion of a five-year term of office by a majority of the city council, or during the five- year term by a vote of three-fourths of the city council."
<u>Charlotte, NC</u>	Appointed.	City Manager. The internal audit function is a division of the Office of the City Manager.
<u>Cincinnati, OH</u>	Appointed.	City Manager. The internal audit function is performed by the Director of Finance. "The council shall have power by majority vote, to create a department of finance and to authorize the city manager to appoint a director of finance and such subordinates...as he sees fit. The council shall prescribe the qualifications and duties of the director of finance and may provide for the administrative organization of the department. The council may transfer to the director of finance or one or more of his subordinates any duties previously performed by the city treasurer or the city auditor, as well as any other powers that it may see fit."
<u>Colorado Springs, CO</u>	Appointed.	Council. "The Council shall appoint by the concurring vote of a majority of its members a...City Auditor, whose duties, compensation, and tenure of office shall be as prescribed by ordinance."
<u>Dallas, TX</u>	Appointed.	Council. "The city auditor shall be appointed by the city council after being nominated in accordance with a nomination procedure established by ordinance."
<u>Des Moines, IA</u>	Appointed.	City Manager. The audit function is supervised by the Director of Finance. "The director of finance shall supervise the audits division of the department of finance. This division shall be responsible for conducting internal audits requiring the examination of accounting records and the reporting and evaluation of accounting data and systems performance."
<u>El Paso, TX</u>	Appointed.	City Manager. "The function of the internal auditor is established as a function of the city manager's office."
<u>Ft. Worth, TX</u>	Appointed.	Council (recommended by City Manager). "The department of internal audit shall be under the direction and control of the city internal auditor, who shall be recommended by the manager and appointed by the City Council."
<u>Kansas City, MO</u>	Appointed.	Council. "The Mayor and Council shall appoint a City Auditor to serve at their pleasure."
<u>Las Vegas, NV</u>	Appointed.	Council. "The City Council shall appoint a City Auditor and fix the salary of that office."
<u>Lawton, OK</u>	Appointed.	City Manager. The Auditing Department reports to the City Manager.
<u>Little Rock, AR</u>	Appointed.	City Manager. The internal auditing function is a division of the Finance Department.
<u>Norman, OK</u>	n/a	The City of Norman does not appear to employ an internal auditor.
<u>Plano, TX</u>	Appointed.	City Manager. The Auditing Department reports to the City Manager.
<u>Sacramento, CA</u>	Appointed.	Council. "The city council shall appoint the city auditor..."
<u>Tucson, AZ</u>	Appointed.	City Manager. The Office of Budget and Internal Audit reports to the City Manager.
<u>Wichita, KS</u>	Appointed.	City Manager. The internal audit function is part of the Administrative Services Division of the City Manager's office.
